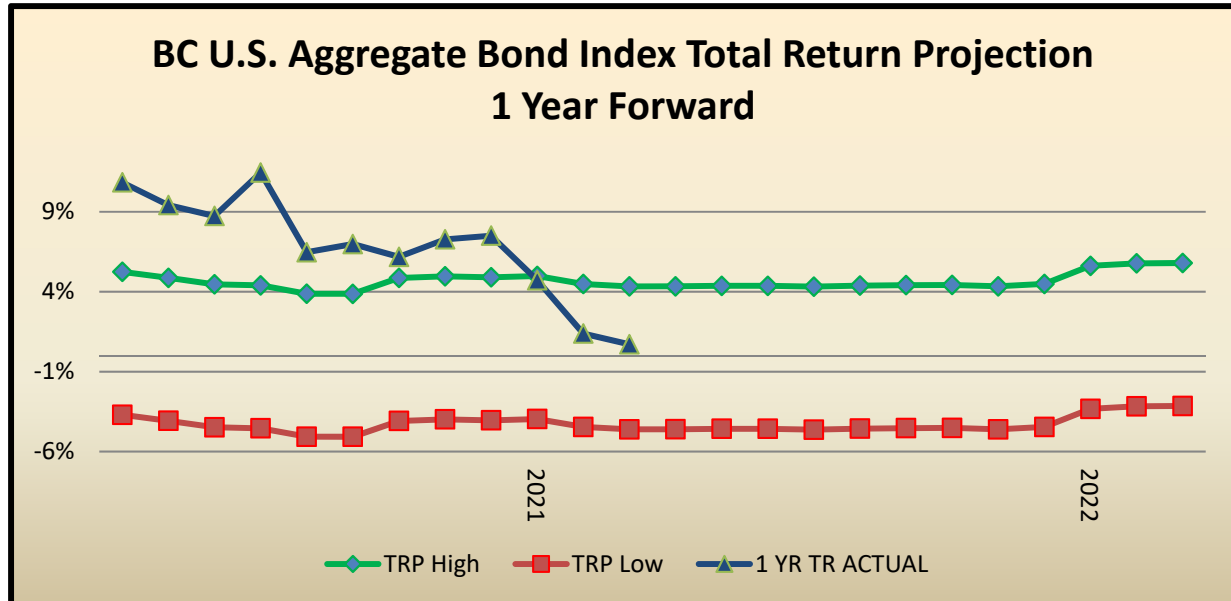
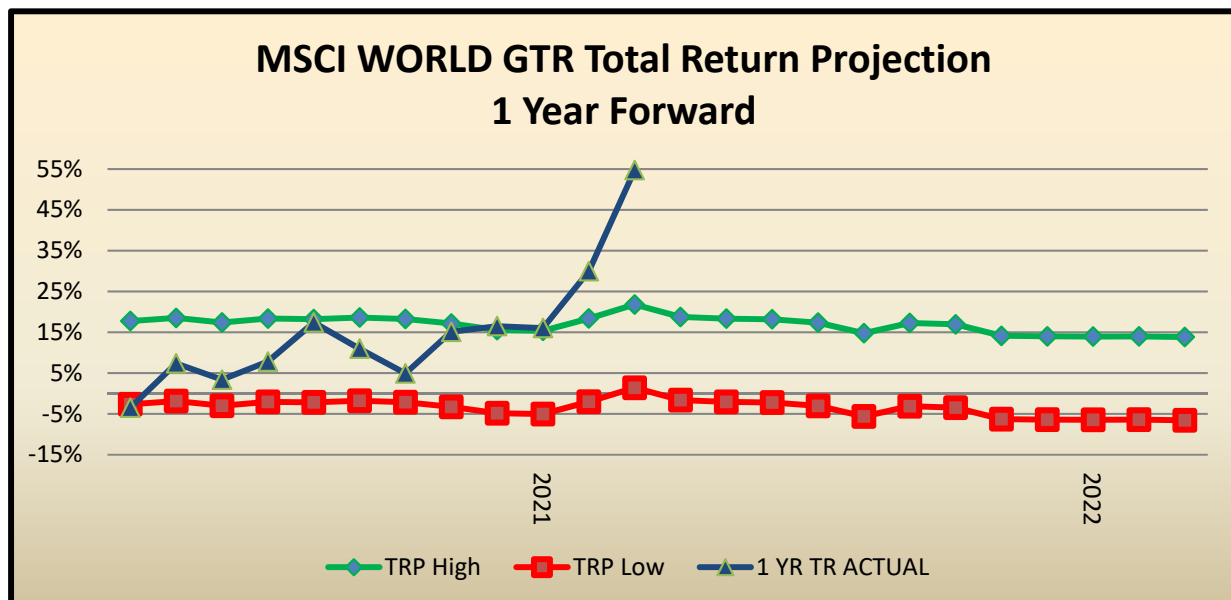


Mench Financial, Inc. Markets Outlook 2Q 2021
