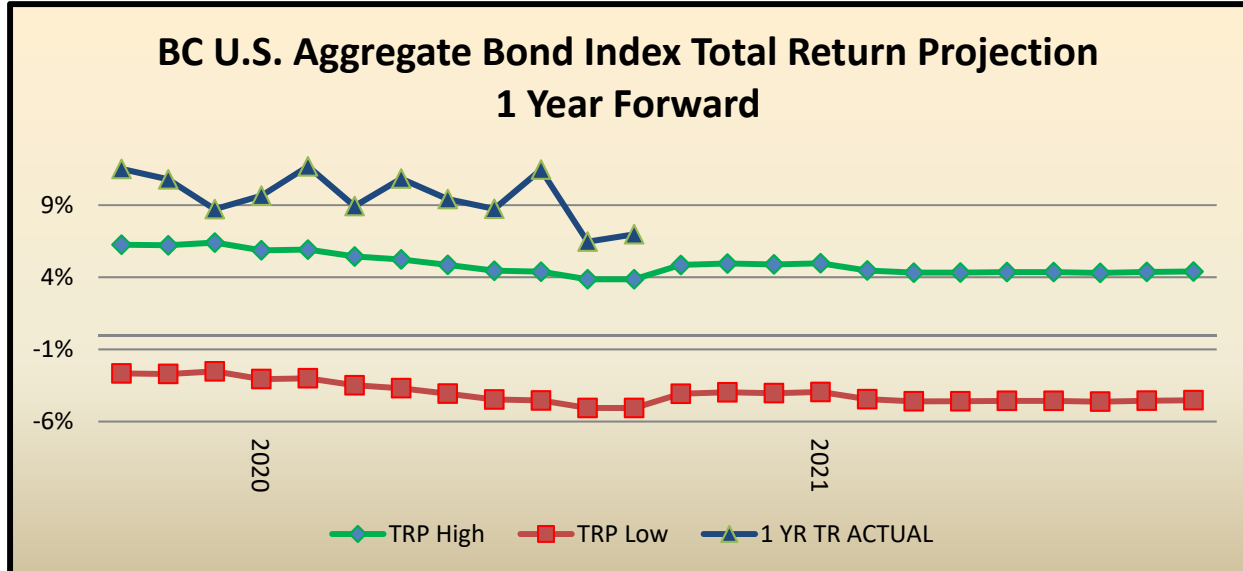
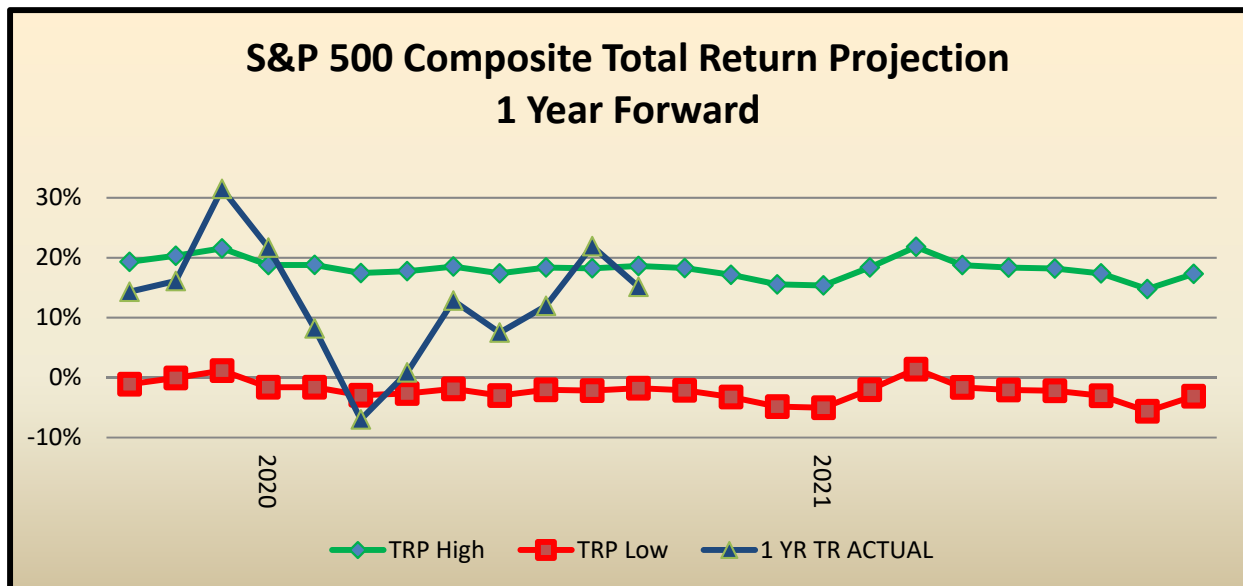


Mench Financial, Inc. Markets Outlook 4Q 2020
